Information for counsel wishing to appear in Court remotely using Virtual Meeting Rooms (VMR)

When can I use VMR?

Subject to the exceptions, counsel may appear using a VMR for all cases in all jurisdictions.

Email the relevant court that you wish to appear via VMR (see '**Key Contacts**' below)

** Use of the VMRs outside of remote court appearances is not permitted.

When must I appear in person?

Unless directed otherwise by the presiding Judge, counsel <u>must</u> appear in person at the Court for:

- 1. Criminal Jurisdiction: Judge Alone Trials
- Family and Civil Jurisdictions: Defended Fixtures

Who else can appear via VMR?

The following people may also attend court remotely by signing into the same VMRs:

- Judge
- Registrar
- Defendants (in Corrections Custody only)
- Victims
- Prosecutors
- Lay Advocates
- Media

When should I sign in to a VMR?

Each VMR suite has a maximum capacity of 20 participants at any one time.

To help ensure all VMR appearances run smoothly:

- Counsel should sign in to the VMR no more than 20 minutes before their scheduled appearance
- Counsel should ensure their device is on mute when signing in to the VMR to avoid disruption to any proceedings underway.

When should I sign out of a VMR?

Unless Counsel have consecutive matters, Counsel should log out of the VMR after each client's appearance.
